### About GU

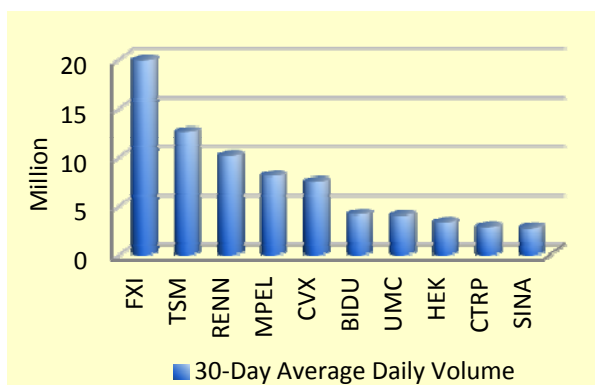
