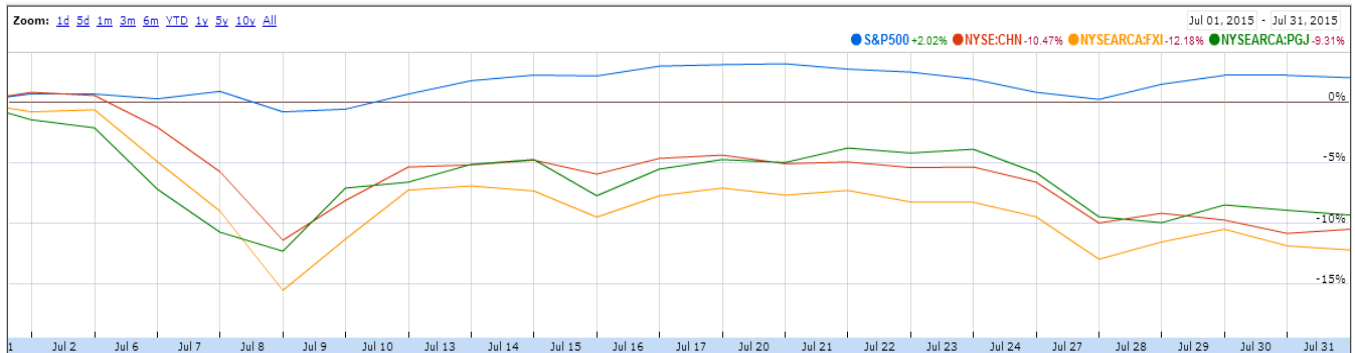

### About XUE

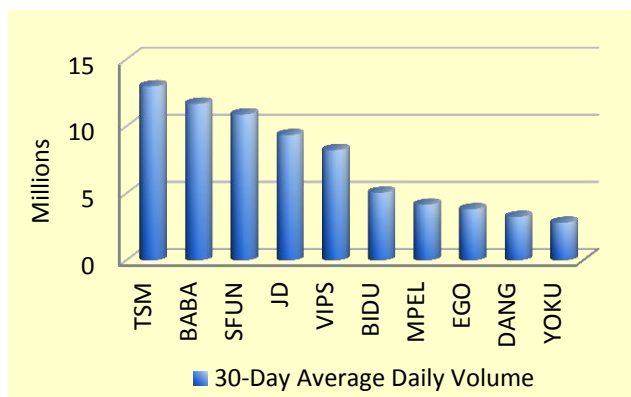
