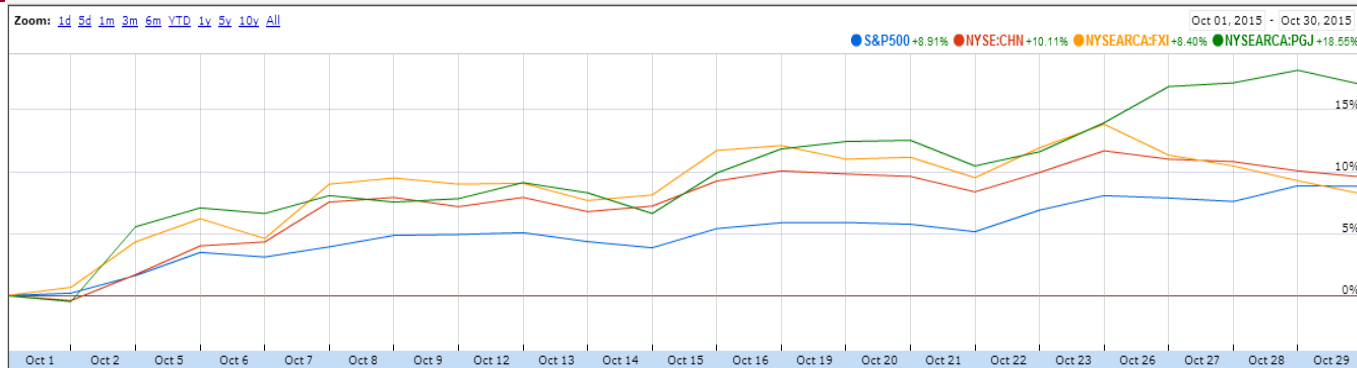

### About CHLN

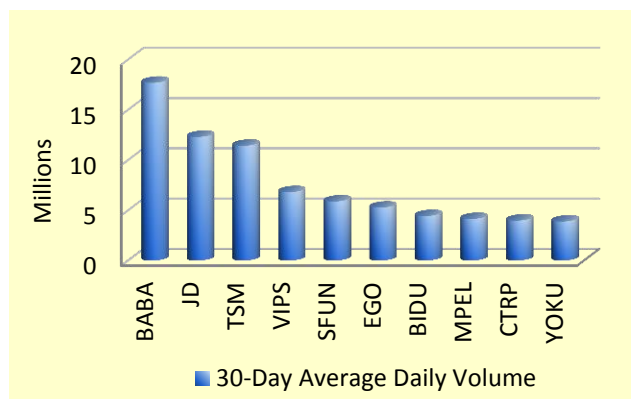
