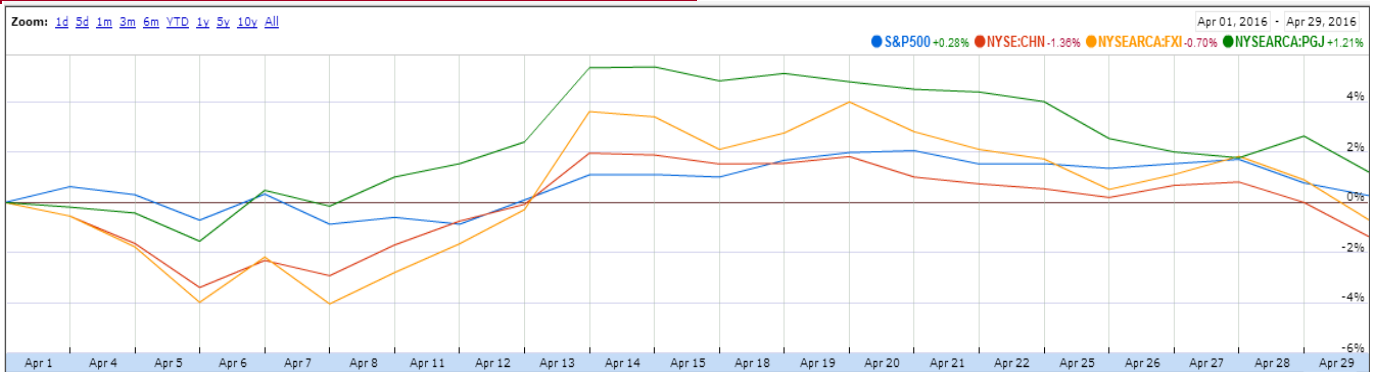

### About QKLS

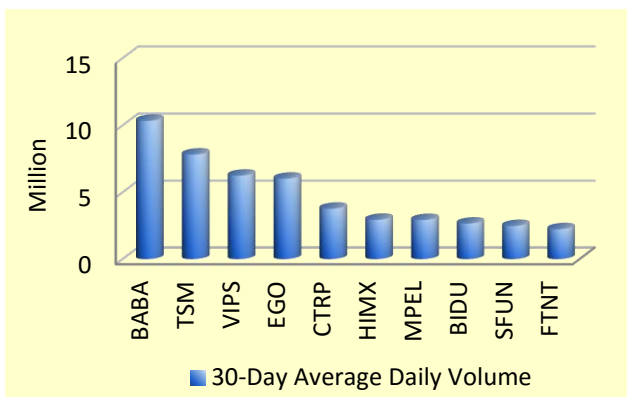
